- We'll install, inspect, test, and maintain the radio receiver used to control your air conditioning without charge. You must allow reasonable access to the radio receiver and any other company-owned equipment.
- Enrollment continues automatically year to year until we receive notification of cancellation. After participating for a full year, you may cancel by calling 800-493-3299.
- 5. You must allow us to control all central cooling equipment at the location of service.
- Maximum cycled control will not exceed 8 hours a day or 300 hours during the summer season, which is June through September.
- We aren't liable for any loss, cost, damage, or injury resulting from interruptions or restorations of service that may occur while you're participating in CoolSavings.
- 8. If you tamper with any load-management equipment located on your property, we may discontinue your participation in CoolSavings and may bill you for expenses to remove company equipment plus investigative charges.
- 9. We reserve the right to deny participation or cancel enrollment in CoolSavings at any time. Reasons for denial or cancellation include, but are not limited to, excessive installation costs, oversized or undersized air-conditioning equipment, or abnormal utilization of equipment, including seasonal homes and other limited-occupancy situations.
