## CoolSavings terms and conditions

1. CoolSavings is a free program available to qualified residential customers.
2. A customer must enroll in CoolSavings for a minimum of one year from the date Otter Tail Power Company installs control equipment at the home.
3. Otter Tail Power Company will install, inspect, test, and maintain the radio receiver used to control the customer's air conditioning without charge. Participants must allow reasonable access to the radio receiver and any other company-owned equipment.
4. Enrollment continues automatically year to year until we receive notification of cancellation. After participating for a full year, a customer may cancel by calling 800-493-3299.
5. A participant must allow the company to control all central cooling equipment at the location of service.
6. Maximum control will not exceed 8 hours a day or 300 hours during the summer season, which is June through September.
7. The company shall not be liable for any loss, cost, damage, or injury resulting from interruptions or restorations of service that may occur while a customer is participating in CoolSavings.
8. If a customer tampers with any load-management equipment located on the customer's property, the company may discontinue the customer's participation in CoolSavings and may bill the customer for expenses to remove company equipment plus investigative charges.
9. Otter Tail Power Company reserves the right to deny participation or cancel enrollment in CoolSavings at any time. Reasons for denial or cancellation include, but are not limited to, excessive installation costs, oversized or undersized air-conditioning equipment, or abnormal utilization of equipment, including seasonal homes and other limited-occupancy situations.
10. CoolSavings participants receive a credit of \$7 per month for participating June through September. Credit applied may be prorated and may change by action of the applicable state regulatory bodies.

## CoolSavings – Join your neighbors to help manage summer’s energy-use peaks

**Enroll** your central cooling system in CoolSavings and **receive up to \$28 per year** for participating.

### What qualifies:

- Central air-source heat pumps or central air conditioning (AC) systems are eligible for this program.
- Only units connected through your main meter (served on the Residential Service or RDC Rates) are eligible for CoolSavings.
- Window units and ductless air-conditioning systems do not qualify
- Units served on a discounted controlled-service rate do not qualify.

### How does the program work:

- The program is active June through September.
- We’ll install our control equipment on the outside of your home.
- During occasional peak periods we’ll cycle your cooling system on a 15-minute on/off schedule.
- In past years customers on CoolSavings have experienced approximately 25 hours of control each summer.
- Most people aren’t aware when cycling occurs.
- You’ll receive a monthly credit on your summer season service statements.
