## NEW SOUTH DAKOTA ELECTRIC RATES BEGIN APRIL 1, 2026

On June 4, 2025, we filed a request with the South Dakota Public Utilities Commission (PUC) to increase electric rates for our South Dakota customers. This request reflects rising costs to maintain a safe, reliable electric system while meeting customers' electricity demands as economically as possible. We last requested a rate review in South Dakota in 2018.

On March 10, 2026, the PUC approved a revenue increase of approximately 7.74% of base rates, or \$3.3 million. This increase takes effect with bills rendered on or after April 1, 2026.

A typical residential customer using 932 kilowatt-hours (kWh) will see an increase of about \$8.97 a month, and a typical business customer using 2,751 kWh will see an increase of about \$17.14 a month. Actual charges may vary based on your rate classification and electricity use.

Interim rates took effect December 1, 2025, allowing a portion of the increase to begin before final rates were approved by the PUC. **Because final rates are lower than interim previous in effect, you won't see an additional increase—and you'll receive a refund with interest in May 2026.** Which will appear on your bill as *Interim Rate Adjustment*.
