Customers requesting rebates must contract for window installations with a contractor.

Rebate details

- 1. Home must be heated with electricity to qualify. Heat sources can include, but aren't limited to the following permanent, hard-wired electric heating options: electric baseboard resistance; electric plenum heaters; boilers; thermal storage room units, central furnaces, and in-floor systems; air source heat pumps; and geothermal heat pumps.
- 2. Windows must be installed in conditioned living space to qualify for rebates.
- 3. Windows must meet ENERGY STAR Version 7.0 Northern Climate Zone to qualify for rebates.
