Sign up today for our Facility Turn-key Efficiency (FTE) program! We've designed our FTE program for customers to identify energy-saving opportunities. We'll assist with implementing these opportunities and provide extra cash incentives for your commitment to completing them.



An energy engineer will visit your facility and perform a whole-building assessment investigating all of your energy-consuming systems including:

- Lighting
- HVAC
- Refrigeration
- Process systems
- Building envelope
- Controls

From these findings, we'll develop a project list identifying low/no cost projects as well as recommended capital improvements to reduce your operating costs and improve energy performance. You'll receive a report detailing each opportunity and its estimated cost, energy savings, and payback—including energy-efficiency rebates from our company.

After your assessment, we'll help you take the next steps toward implementing the opportunities identified. Our level of assistance is completely customized according to your needs and may include project scoping and evaluating bids to filling out rebate applications.

By signing up for an assessment through our FTE program, you're eligible for a 50 percent bonus incentive on top of our standard rebates for any qualifying measure implemented within 12 months of receiving your facility assessment report.

Program details

- Offer available to all Large General Service customers in Minnesota.
- Customer pays \$500 toward facility assessment expenses (usually a \$2,500 value). We'll add the \$500 facility assessment co-pay (per assessment) to your next utility bill.
- Post-assessment consulting and implementation support is free of charge.
- Assessments generally take 3-4 hours on site depending on the size of your facility.
- Program participants are eligible for up to 50 percent bonus incentives* for qualifying measures implemented within 12 months of report delivery.

* Total incentive per measure cannot exceed 75 percent of project cost.
