1. Vehicle rebate will not exceed purchase cost of vehicle.
2. Vehicle must be purchased from qualified dealer. Private to private sale does not meet rebate requirements.
3. **Proof of vehicle purchase** including **copies of vehicle title or registration** must be submitted with this rebate request.
4. Vehicle primary residence must be where electricity is supplied by Otter Tail Power Company.
5. Rebate requests for vehicle purchases during the calendar year noted at the top of page one of this form must be received no later than March 31 of the following calendar year or will not be accepted.
6. Allow 6-8 weeks for processing.
7. Rebate limits apply. Rebate programs are subject to change or cancellation without notice.
8. Acceptance of this application does not guarantee payment. You must meet rebate eligibility requirements.
9. You will be notified if your application is not accepted.
